

ORDINANCE NO. 2018-01

AN ORDINANCE TO AMEND SECTION 52-3 A. OF THE TOWN CODE OF ORDINANCES CHANGING THE LEGAL POSTING AND PUBLICATION LOACTIONS

WHEREAS, Wisconsin Statute 985.01(7), 985.02(2) (a), 985.02(2) (b), 985.02(2) (c), 985.02(3) and 985.08(1) provide a method of notification of legal notices; and

WHEREAS, Under previous law, a municipality must post notice in at least three public places likely to give notice to persons affected, and must post a notice that would be published before the act or event requiring notice no later than the time specified for the first newspaper publication, or if the notice would be published after the act or event requiring notice, must post the notice within one week after the act or event, and

WHEREAS, Under 2015 Senate Bill 137, signed into law on November 11, 2015, a municipality that opts to post a legal notice in lieu of publication may, instead of posting the notice in three public places, post the notice in one public place and publish the notice on the municipality's Internet site.

NOW THEREFORE BE IT ORDAIN: That the Town of Herman, Dodge County, Wisconsin does hereby amend Town of Herman Code of Ordinances Chapter 52-3 B and considers our Town website and the Town Hall Notice Board to be our usual, customary, and legal posting locations.

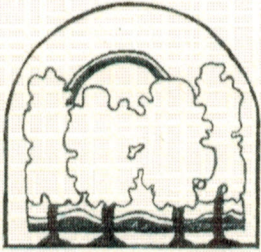
